**Proposal for Partnership and Co-operation between the
Ecological Organisations of Natura Opava (Czech Republic),
and Environmental Society of Preveza (Greece)**

There's been both good relationship between those organisations, Ekological Organisation Natura Opava (Czech Republic), the Town Hall of Preveza and Environmental Society of Preveza (Greece), and also many ecological activities to share for many years. So, accenting those simple facts, it seems to be an appropriate reason to set the agreement deed concerning our mutual cooperation.

We think that our mutual co-operation on particular ecological, culture and tourist projects can support own friendship between ecologists from Preveza and Opava as well as help in nature protection involving both countries.

I.

All parties are willing to continue in active long timed co-operation to reach mutual support while facing ecological tasks or challenges. The mentioned co-operation concerns:

I. information, know-how and experience exchange on the following fields:

environmental protection
ecological propagation

II. particular projects to share in Prevezian region:

1. Elaborate a leaflet for tourists „Ten Stops in Nature of the Preveza area“ (presenting natural and historical attractions (information) to the visitors of the Preveza region, usage for schools) 2011
2. A book „Nature of the Preveza area (Ivan Zwach, Milan Kubačka, Jakub Kubačka
3. Arrangement of the exposition in the Museum 2011 (a new exposition for gaining finances from the EU)
4. To continue in herpetological, batrachological and entomological research in the Preveza area.
5. International meeting of young naturalists and artists in Agii Apostoli (2011, 2012)
6. Create a proposal of the project of Establishment of International Centre of Environmental education in Preveza for the Operational Programme of the EU.

II.

The experience and information exchange involving environmental protection and its propagation should get more intensive. Both the partners will be regularly expected to determine and set appropriate researched branches to which own priority level will be given then later. It should also be told very exactly how to make the particular steps for making deeds come true.

III.

Both sides are individually responsible for their own financial expenses revealed from already-mentioned activities.

To every particular project it should be worked out the proper deed paper.

Both sides are supposed to look for additional financial sources for together projects
Both sides are also ready to start co-operating although having no additional financial sources

IV.

All the steps, taken by both sides while making the deed come true, should correspond with legislative law valid in the Czech Republic as well as in Greece.

V.

Both the partners are supposed to inform the wide public about their activities. In order to make our cooperation or contacts tougher and more effective, both the sides agree to appoint one person from own group. Both those elected persons are expected to co-operate and also prepare a terminal information booklet in the end of every year.
Both the signers are supposed to evaluate their cooperation of every ending year as well as to work out the new program for a following year. The dates and places for that should be determine before.

VI.

The deed is worked out in three versions, in Greek and English languages. Each side will be given one Greek and one English version.

Amendment

Natura Opava (Czech Republic) will inform the Town Hall of Preveza as well as Prevezian Environmental Society about all the results concerning its ecological research.
Natura Opava (Czech Republic) offers its web sites to set mutual propagation of both the ecological organisation.
Both the sides are supposed to keep the Nature Museum of Neochori tidy and in appropriate order.
